



### 3 – Fees for the Issue of a Digital Signature Certificate

⇒ **This section should only be completed if there is no specific prior agreement with Notarius Inc.**

The issue of a digital signature includes the creation of data on the servers, transmission of activation codes to the member, management of revoked certificate lists, maintenance of security levels, and application updates. **Please check one of the following two options:**

**APPLICATION FOR THE ISSUE OF A DIGITAL SIGNATURE:**

For a **first request for a digital signature, or a second or subsequent request made more than three (3) months** following the date of cancellation (non-activation of a digital signature), expiration (non-renewal of keys and certificates) or revocation of an application, fees for issuing a digital signature are **\$140 plus applicable taxes** per certificate. This fee includes delivery of the codes.

**REQUEST FOR A RE-ISSUE OF A DIGITAL SIGNATURE:**

For a **second or subsequent request for a digital signature made within three (3) months** following the date of cancellation (non-activation of a digital signature), expiration (non-renewal of keys and certificates) or revocation of an application, fees for issuing a digital signature are **\$50 plus applicable taxes**. This fee includes management and issue of activation codes.

### 4 – Annual Fees for the Use of a Digital Signature

⇒ **This section should only be completed if there is no specific prior agreement with Notarius Inc.**

The annual fees of \$195 must be paid to maintain the validity of the member's digital signature certificate and access to the telephone support services provided by Notarius from 8:00 a.m. to 5:30 p.m. EST, Monday to Friday.

### 6 – Consent Regarding Personal Information

**Verification of identity by an identity verification agent (IVA)**

I understand that my identity must be verified by an identity verification agent (IVA) authorized by the OIQ in order for a digital signature certificate be issued to me. I authorize the IVA authorized by the OIQ to collect my personal information including a copy of two (2) pieces of identification (one with photo) in order to confirm my identity. I understand that this collection of information is necessary and I consent to the IVA holding this information for his/her records for as long as deemed useful as proof that he/she has performed the verification of my identity.

**Transfer of information between the IVA authorized by the OIQ and the QCC**

I authorize the IVA authorized by the OIQ to share the information collected in this form to the QCC for the purposes of issuing and managing my digital signature certificate. I also authorize the IVA to send any notices regarding my professional status to the QCC.

**Transfer of information between the QCC and the IVA authorized by the OIQ**

I authorize the QCC to send any notices regarding the status of my digital signature certificate (for example, issuance, recovery, non-renewal, cancellation, suspension or revocation) to the IVA authorized by the OIQ.

**Holding and use of information by the IVA authorized by the OIQ and the QCC**

I consent that the IVA authorized by the OIQ and QCC use the information collected, as well as any information related to my digital signature certificates, for any purposes related to the services provided for its management and that they be kept as long as deemed useful. More specifically, I authorize the QCC to keep a copy of my public decryption key.

**Content and publication of the certificate**

I authorize the QCC to include in my digital signature certificate the information specified in section 1 of this agreement. I recognize that my certificate is of a public nature and I consent that the QCC make it accessible by publishing it in a directory.
